



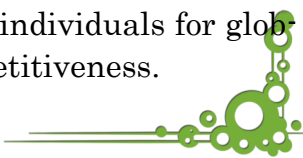
CvSU VISION

(jointly issued by CHED and DBM, joint circular 2017-1)

WHAT: TUITION ONLY

Tuition-refers to matriculation fees or school charges per unit or units of the subjects or courses enrolled in by a student as indicated in the prospectuses of CvSU, which may either be on a term or yearly basis.

WHO ARE QUALIFIED?

All Filipino students enrolling in undergraduate course programs in State Universities and Colleges (SUCs) for the Academic Year 2017—2018, subject to prioritization directive of the President and the availability of funds in the Higher Education Support Funds (HESF).

STUDENT PRIORITIZATION:

Note: Student must be academically able

(refers to enrolling students who pass the academic and retention standards of the university)

1. Student Financial Assistance Program (StuFAP) beneficiaries

2. Continuing students*

- a. Graduating students
 - i. With one semester remaining, regardless of household per capita income.
 - ii. With one academic year remaining, regardless of household per capita income.
- b. Non-graduating students
 - i. Who belong to a household that is or was a beneficiary of 4Ps.
 - ii. Who were never part of a household that is or was a beneficiary of 4Ps but still included in the Listahanan 2.0 ranked according to their estimated per capita household income.

- iii. Neither i nor ii; ranked according to per capita household income based on submitted documentation (s) for proof of income.

IF THERE ARE STILL REMAINING FREE TUITION FUNDS:

3. New enrollees** and returning students***

- a. Graduating students
 - i. With one semester remaining, regardless of household per capita income.
 - ii. With one academic year remaining, regardless of household per capita income.
- b. Non-graduating students
 - i. Who belong to a household that is or was a beneficiary of 4Ps.
 - ii. Who were never part of a household that is or was a beneficiary of 4Ps but still included in the Listahanan 2.0, ranked according to their estimated per capita household income.
 - iii. Neither i nor ii; ranked according to per capita household income based on submitted documentation(s) for proof of income.

HOW TO AVAIL?

Interested applicants must proceed at the Office of Student Affairs and Services, secure and fill out Free Tuition 2017 application form and bring the following:

1. School ID or StuFAP or 4P's ID
2. Original copy of documentation for proof of income (any of the following):

(excluded for StuFAP and 4P's grantees)

- a. Income Tax Return (ITR)
- b. BIR Form 2316
- c. BIR Certificate of Exemption from Filing of ITR

- d. Barangay Certificate of Indigency
- e. Certification from the DSWD
- f. Overseas Filipino Worker (OFW) Certificate
- g. Employment Contract for OFWs
- h. Other government-issued documents that indicate the income earnings of member(s) of the household who would be responsible for the financing of the student's cost of education

WHERE TO SUBMIT?

Office of Student Affairs and Services (OSAS) for initial screening.

HOW TO KNOW IF APPROVED TO AVAIL?

The names of the Free Tuition grantees will be posted on the bulletin boards of OSAS and respective colleges/campuses and CvSU website.

WHEN TO APPLY?

June 5, 2017—July 24, 2017

* refers to enrolling students who were enrolled in the same university in the previous semester

** refers to students enrolling in the university for the first time

*** refers to enrolling students in the university who were not enrolled in the regular semester before the current one, but were enrolled in the same university at least once in previous semesters
